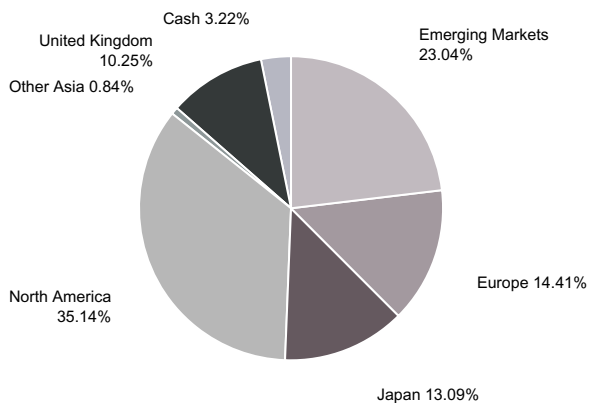

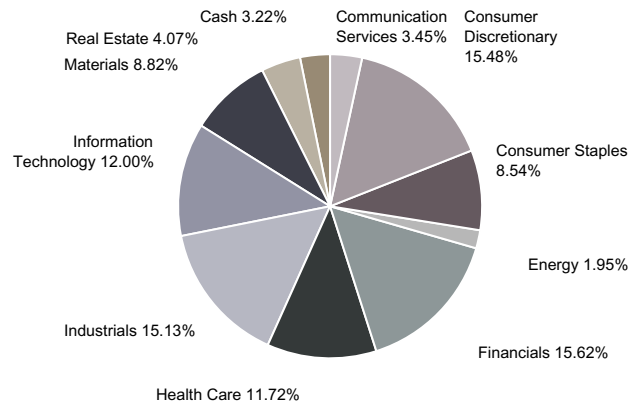

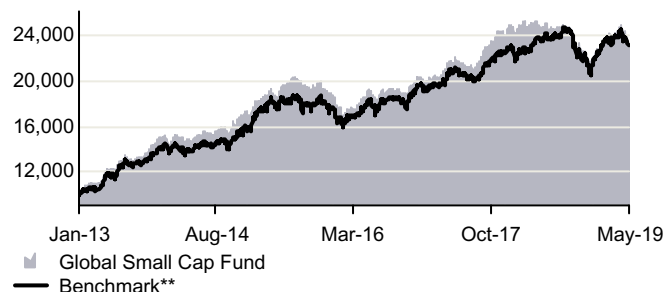
## Region Allocation (%)
