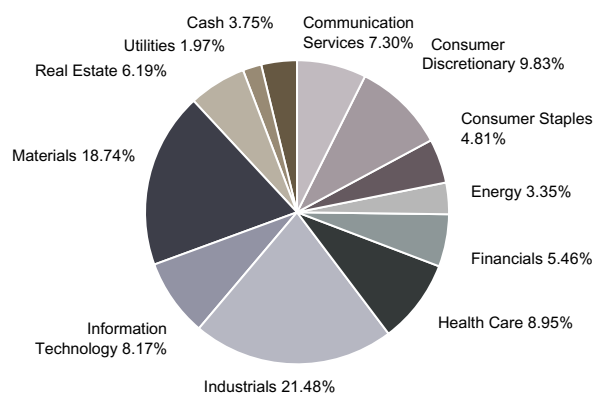

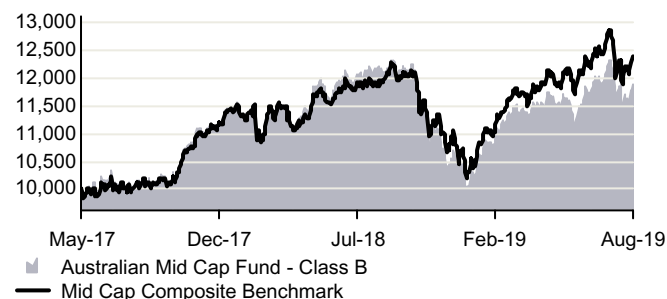
Sector Allocation (%)
