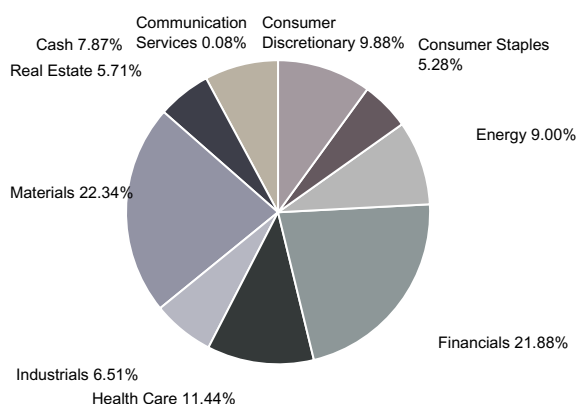

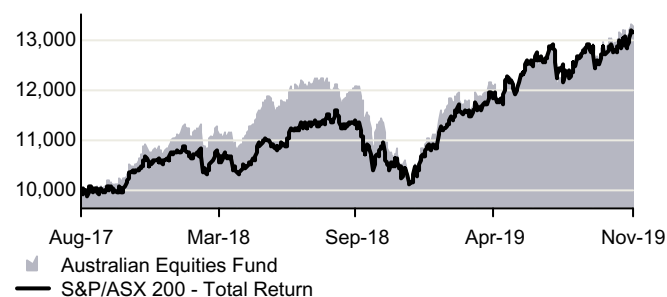
Sector Allocation
