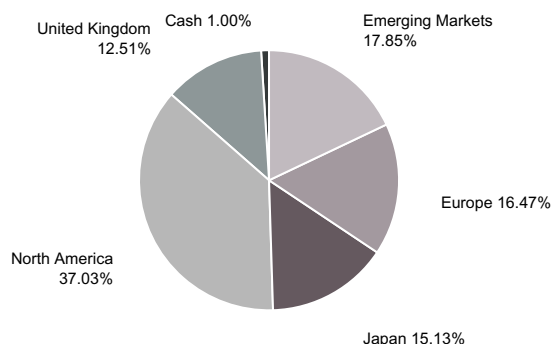

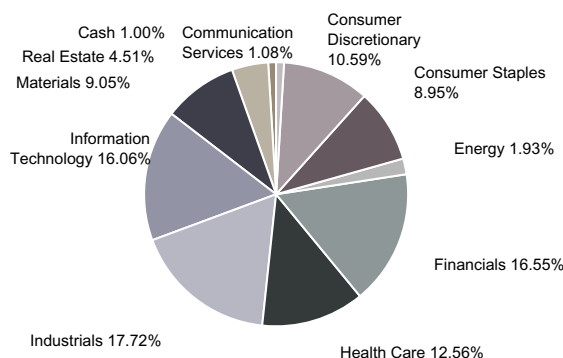

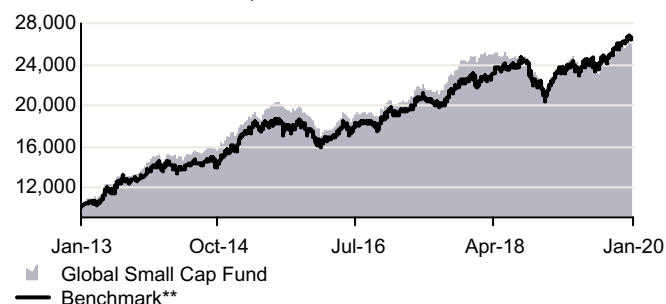
Region Allocation
